Farm Visits - Sponsored by









During the visit at Pest Control Products Board (PCPB), you will get an opportunity to interact with PCPB officers and get to learn more about how pest control products are regulated in Kenya. You will also get to learn how PCPB is tackling various challenges related to use of pesticides in the country. You will tour our state-of-the-art laboratory where pest control products are analyzed to ensure that products availed in the market meet the set standards. You will also learn more about the new division in the laboratory whose function is to conduct pesticide residue analysis in agricultural commodities, soil and water.



Delegates visiting Plantech Kenya Limited in Naivasha will learn about its role as a leading nursery and plant propagation company, established in 2016 to provide high-quality, disease-free seedlings to farmers across the country. The company propagates a wide range of vegetables, herbs, fruit trees, flowers, and other crops using advanced techniques such as vegetative propagation and tissue culture. With over 150 varieties and services that include farm visits, training, and nationwide delivery, Plantech Kenya has transformed seedling production, improved farming practices, and supported food security while engaging with the community through initiatives like Plantech FC.



Kamuthanga Farm in Machakos County is one of Africa's most innovative aquaculture enterprises. The farm is best known for its Recirculating Aquaculture Systems (RAS), which allow for the production of Nile tilapia, African catfish, and ornamental fish such as goldfish and koi carp. With an annual capacity of about 100 tonnes, the farm demonstrates how technology and sustainability can go hand in hand. Beyond aquaculture, Kamuthanga Farm integrates crop farming, piggery, poultry, and rabbit rearing, creating a model of circular agriculture where waste and resources are shared across enterprises. The farm became the first in Africa to achieve EcoMark certification from the African Organisation for Standardisation (ARSO), a milestone that underscores its leadership in sustainable aquaculture.



During the visit to Fresh Del Monte, delegates will be taken on a guided tour of the pineapple fields to see firsthand how pineapple crops at different growth stages up to harvesting are cultivated and managed. This will be followed by a walk through the packing house to observe the processes that prepare fresh pineapple products for market. The visit will provide insight into the journey from farm to table, showcasing both the agricultural practices in the fields and the careful handling, sorting, and packaging that ensure quality produce reaches consumers.



Naivasha Inland Container Depot (NICD)

During the visit, delegates will gain firsthand insight into the Naivasha Inland Container Depot (NICD) and its critical role in supporting trade and logistics. They will tour key facilities including the truck marshalling yard, cargo entry and exit gates, operations control center, and the SGR-MGR interchange. Delegates will also observe the stacking yard, reefer plugging points for perishable goods, and the supportive amenities such as the banking hall, cafeteria, and washrooms. Additionally, they will be introduced to operational systems like KWATOS and view specialized equipment, highlighting the depot's efficiency in facilitating seamless cargo handling and regional connectivity

Nairobi Inland Container Depot

During your visit we shall take you through:

- Online and real-time submission & tracking of Reefer containers documentation at the comfort of your Office using Kwatos System End to End.
- 2. 336 Reefer plugging in points.
- 3. Yard and Rail handling equipment.
- 4. Operations Control Center.
- 5. I-Gate /Smart Gate Operations.
- 6. KRA Scanners
- 7. PGAs and Transit Countries representation at ICD.
- 8. ICD Police Station for cargo and staff security.



During the visit to Mitchell Cotts Air Cargo Terminal at JKIA, delegates will gain firsthand insight into the operations and infrastructure supporting Kenya's air freight logistics. The program will begin with a welcome and security briefing, followed by introductions and an overview of air cargo solutions presented by the terminal's management team.

Delegates will then embark on a guided tour of the Air Cargo Facility, led by warehouse operations experts, to observe key processes including cargo handling, storage protocols, and compliance measures. A group photo session will capture the moment before the delegation proceeds to Logistics Centre 1 for specialized facility tours.

At the logistics centre, delegates will explore two critical export hubs: The Avocado Facility, showcasing cold chain management and packaging standards for fresh produce and The Coffee Facility, highlighting quality control, traceability systems, and export readiness. This visit will offer valuable exposure to Kenya's air cargo ecosystem, emphasizing efficiency, safety, and the role of specialized infrastructure in supporting global trade.
